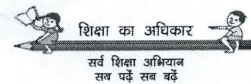

Expression of interest for hiring a Technical Agency for Development and

➤ **Background**

The Government of Bihar is committed to improve Water, Sanitation and Hygiene (WASH) standards in schools across the state. As part of this commitment, the Bihar Swachh Vidyalaya Puraskar (BSVP) has been conceptualized as a state-specific benchmarking and incentive system to promote WASH in School (WinS). The objective is to recognize, encourage and reward schools which demonstrate excellence and innovation in WASH service delivery.

The Bihar Swachh Vidyalaya Puraskar (BSVP) is anchored on a comprehensive framework of 50 well-defined indicators that span key domains of WASH in Schools-including infrastructure, operation and maintenance, hygiene promotion, menstrual hygiene management (MHM), water quality, hand hygiene and behavior change practices. Schools are encouraged to self-nominate through a standardized digital application process. Based on their responses, schools are assigned a star rating which reflect their level of WASH compliance and performance. Eligible schools, as per the defined benchmarks, are subsequently shortlisted for district-level evaluation, with top-performing schools progressing to state-level assessment and recognition.

To facilitate efficient, transparent and scalable implementation of BSVP, the state intends to engage a qualified technical agency to develop and manage a comprehensive web and mobile-based application platform which supports the end-to-end process from self-nomination to assessment and recognition.

➤ **Objective of the EOI**

This Expression of interest (EOI) invites proposal from reputed and experienced technical agencies for the design, development, deployment and management of a secured, user-friendly and scalable digital platform comprising both web

application with mobile optimized UI to operationalize the Bihar Swachh Vidyalaya Puraskar (BSVP).

The core objective of this assignment is to build an integrated digital system that:

- Enables schools to self-nominate for BSVP by submitting structured data aligned with the defined 50 WASH indicators.
- Supports multi-tiered access (school, block, district, state) with customized, role-based dashboards for real-time monitoring and management.
- Facilitates transparent evaluation, including geo-tagging, automated scoring and secured upload of document and photograph as evidence.
- Provides advanced analytics, reporting and visualization tools to support data-driven decision-making by administrators.
- Ensures continuous operation and maintenance, including capacity building, user training and technical support via a dedicated helpdesk.

➤ **Scope of Work**

The selected agency will be responsible for:-

- Designing a responsive web application with mobile-optimized UI (no separate mobile app needed).
- Enabling school-level registration and self-nomination as well as District and State level evaluation of eligible schools based on 50 WinS indicators.
- Developing role-based dashboards for block, district and state officials.
- Facilitating online assessment, verification and ranking mechanisms.
- Incorporating data validation, photo uploads and GIS tagging.
- Ensuring data security, privacy and user authentication protocols.
- Providing training and user manuals for administrators and school users.
- Offering technical support and maintenance for a minimum period of 6 months starting from the date of project delivery under BSVP initiative.
- Enabling data export, analytics and report generation features.

➤ **Eligibility Criteria**

Interested agencies must fulfill the following minimum criteria:

- Minimum 5 years of experience in developing web/Mobile friendly web portal, preferably in the education or WASH sector.
- Prior experience with government or large-scale digital platforms.



- A brief company profile.
- Details of relevant past projects.
- Summary of technical capabilities and team structure.
- Initial understanding of the project and proposed approach.
- Valid registration and statutory document.
- The EOI must be submitted in a sealed envelope or via email (as applicable) with the subject line. "EOI for Development and management of BSVP web application with mobile-optimized UI" (no separate mobile app needed).


➤ **Selection process**
