On Page 3, Clause No. 2.2 -It is mentioned that " The purpose of this RFP is to seek the services of reputed IT firms/agencies to design, develop, test, implement, operate and maintain the Project Education Bihar Council's Web Portal for at least 3 year". Here we would understand to expectations under term "operate". Do we need to provide an onsite resource and operation for maintenance

On Page 7, Point No. 9 - It is mentioned that "The bidder must have obtained GIGW Compliance Certificate from STQC for at least three of its web project of application/portal/website". So here we would like to request you to allow us an STQC from exemption certificate, though we can provide you three projects with CERT-In Certificate.

On Page No. 22 PART A Point No. 2, please clarify, do we need to provide the costing of hosting monthly, annually or for complete three years.

In our RFP, there is no exemption on EMD for MSMEs. Now, it is not feasible to consider your request to provide exemption on EMD

The term "operate" means that you have to hand-over the website fully operational.

No, you need not provide an onsite resource for operation and maintenance. But you have to provide support for operation and maintenance.

Considering discussions and points raised by firms related to GIGW Compliance Certificate from STQC, it is decided to waive the GIGW compliance certificate from clause 9 of the page -7 (pre-qualification criteria) for healthy and wide competition.

You have to provide cost for complete tenure i.e. 5 (five) years.

Prospective bidders are requested to take note of the changes/modifications and submit their bids accordingly.
