All 19 (nineteen) technical bids were examined by the Technical Evaluation Committee in the light of the criterion as laid down in the advertisement as well as in the detailed RFP document and an 'Evaluation Chart' was prepared (will form part of the proceedings). The eligibility as well as the suitability of the bidders in the perspective of the desired digitization work was examined.

Based on the evaluation of bids on the basic of the responsiveness to the RFP & TOR, the unanimous observation/view/recommendations of the Technical Evaluation Committee are as under:-

(a) The bidder at **Sl.No. 4 & 5** (Technical Evaluation Chart) i.e. "M/s. VISTAR VISION", patna and "M/s. ABM Associates", Patna respectively may be treated as "**Responsive**" in terms of responsiveness of RFP & TOR.

Ltd", Patna' may be treated as "Non-Responsive" in the pretext that the bidder do not have requisite turnover of Rs. 60.00 Lakhs during the Financial Year: 2012-13 as per the books of accounts / certificate submitted. The financial bid of the firm may be returned un-opened.
- (c) The Bidder at Sl.No. 01, 03, 06-19 has not supported some of the evidence(s) / documents (s) as desired in the RFP (mentioned in Column P of the evaluation chart), as such, supplementary information / evidence / clarification if any may may sought from these bidders for further technical evaluation. If the bidders in question fails to submit the supplementary information / evidences/clarifications within the stipulated deadline, the bids may be treated as "Non-Responsive" and their financial bids may be returned un-opened.

The recommendations of the Technical Evaluation Committee are placed before the State Project Director / Purchase Committee for consideration and necessary decision.
